To The Board of Directors, Tyche Industries Limited.

- 1. We have reviewed the accompanying statement of unaudited financial results of Tyche Industries Limited (The "Company") for the Quarter ended 30th June, 2025, (the "Statement") results for the period from 1st April, 2025 to 30th June, 2025 attached herewith, being submitted by the company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
- 2.
