This is with reference to the Annual Report of the Company for the Financial Year 2025-26, which was circulated to the Members on 2nd September 2026.

We wish to inform you that due to an inadvertent printing error, the explanatory notes pertaining to Point No. 36 – Ratio Analysis under the Notes to the Financial Statements appearing on Page No. 128 of the Annual Report were incorrectly printed.

Accordingly, the explanatory notes under Point No. 36 – Ratio Analysis on Page No. 128 are hereby replaced with the following corrected notes:

Note 1: Decrease in ratio is on account of incremental decrease in Current Liabilities compared to the level of decrease in Current Assets during the year when compared to previous year.

Note 2: Due to decrease in Net profit during FY 2025-26 by Rs. 551 Lakhs as compared to FY 2024-25 on account of decrease in revenues during FY 2025-26 by Rs. 1,184 Lakhs compared to FY 2024-25.

Note 3: Due to decrease in purchases during FY 2025-26 when compared to FY 2024-25.

Note 4: Due to decrease in EBIT during FY 2025-26 when compared to FY 2024-25.

The above corrected explanatory notes shall be read in place of the explanatory notes inadvertently printed on Page No. 128 under Point No. 36 – Ratio Analysis of the Annual Report for the Financial Year 2025-26.

Further, it is hereby clarified that there is also a correction in Point No. 37 – Ratio Analysis appearing on Page No. 127 of the Annual Report, specifically in the “Variance in Comparative Figures (%)” column only. The said percentages have been inadvertently stated incorrectly and have been corrected in the updated Annual Report being filed along with this Corrigendum.

The Ministry of Corporate Affairs (“MCA”) vide its circular dated May 5, 2020 read with circulars dated April 8, 2020, April 13, 2020, January 13, 2021 and May 5, 2022, September 25, 2023, 9/2024 dated September 19, 2024 and the latest being 03/2025 dated September 22, 2025 and all other relevant circulars issued from time to time (collectively referred to as “MCA Circulars”) and SEBI vide its Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020, SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021 and SEBI/HO/CFD/CMD2/ CIR/P/2022/ 62 dated May 13, 2022, September 25, 2023, The Securities and Exchange Board of India (“SEBI”) also vide its Circular dated October 3, 2024 (collectively referred to as “SEBI Circulars”) has permitted the holding of the Annual General Meeting (“AGM”) through VC / OAVM, without the physical presence of the members at a common venue. In compliance with the provisions of the Companies Act, 2013 (“Act”), SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”), and MCA Circulars, the AGM of the Company being conducted through VC / OAVM”. Central Depository Services Limited(‘CDSL’) will be providing facility for voting through remote e-voting and CIL Securities Limited for participation in the AGM through VC/OAVM facility and e-voting during the AGM. The procedure for participating in the meeting through VC/OAVM is explained at Note No. 30 below and is also available on the website of the Company at www.tycheindustries.net

1. Pursuant to the provisions of the Act, generally a member entitled to attend and vote at the AGM is entitled to appoint a proxy to attend and vote on his/her behalf and the proxy need not be a Member of the Company. Since this AGM is being held pursuant to the MCA Circulars through VC / OAVM, physical attendance of Members has been dispensed with. Accordingly, the facility for appointment of proxies by the Members will not be available for the AGM and hence the Proxy Form and Attendance Slip are not annexed to this Notice.
2. Institutional/Corporate Members (i.e., other than individuals/HUF, NRI, etc.) are required to send a scanned copy (PDF/JPG Format) of its Board or Governing Body Resolution/Authorization etc., authorising its representative to attend the AGM through VC / OAVM on its behalf and cast their votes through e-voting.
3. The Statement pursuant to Section 102 of the Companies Act, 2013 in respect of special businesses is annexed hereto and forms part of the Notice.
4. Brief resume of Director proposed to be appointed/ re-appointed at the ensuing Annual General Meeting in terms of Regulation 15 and 27 under (Listing obligations and disclosure requirements) Regulations, 2015 is annexed to the Notice. The Company is in receipt of relevant disclosure / consents from the Directors pertaining to their appointment / re-appointment.
5. Pursuant to Regulation 42 of the LODR Regulations, 2015, Register of Members and Share Transfer Books of the Company will remain closed from Thursday, 24th September, 2026 to Wednesday, 30th September, 2026 (both days inclusive) for the purpose of Annual General Meeting.
6. Members whose shareholding is in physical form are requested to notify immediately any change in their address or bank mandates to the Company/ Registrar & Share Transfer Agents quoting their Folio Number and Bank Account details along with self-attested documentary proof. Members holding shares in electronic form may update such details with their respective Depository Participants(s). Members are encouraged to utilise the Electronic Clearing (ECS) for receiving dividends.



7. The Board of Directors of the Company at their meeting held on May 28, 2026 have recommended a dividend of Rs. 3.50/- per equity shares of Rs. 10/- each dividend for the financial year 2025-26. Dividend, if declared will be credited / dispatched after 30th September 2026 but within the time limit to those members whose names shall appear on the Company's Register of Members on 23rd September, 2026 and in respect of the shares held in dematerialized form, the dividend will be paid to members whose names are furnished by National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as beneficial owners as on that date.
8. The Register of Directors and Key Managerial Personnel and their shareholding maintained under Section 170 of the Act, the Register of Contracts or Arrangements in which the directors are interested, maintained under Section 189 of the Act, and the relevant documents referred to in the Notice will be available electronically for inspection by the members during the AGM. All documents referred to in the Notice will also be available electronically for inspection without any fee by the members from the date of circulation of this notice up to the date of AGM. Members seeking to inspect such documents can send an email to cs@tycheindustries.net.
9. SEBI vide its Circular dated March 16, 2023 mandated furnishing of PAN, KYC details (i.e. postal address with pin code, email address, mobile number, bank account details) and Nomination details by holders of physical securities. It may be noted that any service request or complaint can be processed only after the folio is KYC compliant. In terms of the above Circular, folios of physical shareholders wherein any one of the above said details such as PAN, email address, mobile number, bank account details and nomination are not available, are required to be frozen with effect from October 1, 2023 and such physical shareholders will not be eligible to lodge grievance or avail service request from the RTA of the Company and will not be eligible for receipt of dividend in physical mode. Further, Shareholders holding shares in physical form are requested to ensure that their PAN is linked to Aadhaar to avoid freezing of folios. Such frozen folios shall be referred by RTA/Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and or Prevention of Money Laundering Act, 2002, after December 31, 2025. Members holding shares of the Company in physical form are requested to go through the requirements hosted on the website of the Company at cs@tycheindustries.net

In terms of SEBI Master Circular SEBI/HO/MIRSD/POD-1/P/CIR/2024/37 dated May 07, 2024 it is mandatory to furnish PAN, KYC details and Nomination by holders of physical securities and provides that any dividend/ interest to the security holders (holding securities in physical form), whose folio(s) do not have PAN or Choice of Nomination or Contact Details or Mobile Number or Bank Account Details or Specimen Signature updated, shall be eligible for any payment of dividend/interest, through electronic mode only with effect from April 01, 2024, upon their furnishing all the aforesaid details in entirety. It shall be mandatory for all holders of physical securities in listed companies to furnish PAN, Nomination, Contact details, Bank A/c details and Specimen signature for their corresponding folio numbers. Accordingly, it is once again reiterated that it is mandatory for all holders and claimants of physical securities to furnish all the above mentioned details to RTA. Members may please note that SEBI vide its Circular No. SEBI/ HO/MIRSD/MIRSD_RTAMB/P/ CIR/2022/8 dated January 25, 2022, has mandated the listed companies to issue securities in dematerialized form only while processing service requests viz. Issue of duplicate securities certificate; claim from unclaimed suspense account; renewal / exchange of securities certificate; endorsement; sub-division/splitting of securities certificate; consolidation of securities certificates / folios; transmission and transposition. Accordingly, Members are requested to make service requests by submitting a duly filled and signed Form ISR - 4 / ISR - 5, the format of which is available on the Company's website at www.tycheindustries.net . It may be noted that any service request can be processed only after the folio is KYC Compliant.

The Securities and Exchange Board of India has made it mandatory for all companies to use the bank account details furnished by the depositories for depositing dividend through National Electronic Clearing Service (NECS) to investors wherever NECS and bank details are available if the Company proposes to avail NECS Facility. The Company will be availing the NECS facility for the payment of dividend of financial year 2025-26. The bank details are required to be updated for the members who will be availing this facility..

10. Members are requested to note that dividends not encashed or remaining unclaimed for a period of 7 (seven) years for the date of transfer to the Company's Unpaid Dividend Account, shall be transferred to the Investor Education and Protection Fund ("IEPF") established by the Central Government. Further pursuant to the provisions of Section 124 of the Act read with the Investor Education and Protection Fund authority (Accounting, audit, Transfer and Refund) Rules, 2016 ("IEPF Rules") as amended to date, all shares on which dividend has not been paid or claimed for seven consecutive years or more shall be transferred to IEPF Authority as notified by the Ministry of Corporate Affairs.

The Members/claimants whose shares, unclaimed dividend IEPF may claim the shares or apply for refund by making an application to IEPF Authority in form IEPF 5 (available on www.iepf.gov.in) along with requisite fees as decided by it from time to time. The Members/claimant can file only one consolidated claim in financial years as per IEPF Rules.

It is in Members' interest to claim any un-encashed dividends and for future, opt for Electronic Clearing Services, so that dividends paid by the Company are credited to the Members' account on time.

Members who have not yet encashed the dividend warrants, from the financial year ended 31st March, 2019 and onwards are requested to forward their claims to the Company's Registrar and Share Transfer Agent. It may be noted that once the unclaimed dividend is transferred to IEPF as above, no claim shall rest with the Company in respect of such amount. It may also be



noted that the unclaimed dividend amount which were lying with the company up to the year ended on 31st March, 2018, have already been transferred to IEPF. The details of the unclaimed dividends are available on the Company's website at www.tycheindustries.net and on the website of Ministry of Corporate Affairs at www.mca.gov.in. Members are requested to contact the Company's Registrar and share transfer Agent – CIL Securities Limited, R R Towers, C A Lane, Abids, Hyderabad – 500001, Telangana, to claim the unclaimed/unpaid dividends.

11. Pursuant to Finance Act 2020, dividend income will be taxable in the hands of shareholders w.e.f April 1, 2020 and the Company is required to deduct tax at source from dividend paid to shareholders at the prescribed rates. For the prescribed rates for various categories, the shareholders are requested to refer to the Finance Act, 2020 and amendments thereof. The shareholders are requested to update their PAN with the Company/ RTA M/s. CIL Securities Limited (in case of shares held in physical mode) and depositories (in case of shares held in demat mode)
 - a. Resident individual shareholder with PAN and who is not liable to pay income tax can submit a yearly declaration in Form No. 15G/15H, to avail the benefit of non-deduction of tax at source by email to cs@tycheindustries.net latest by September 23rd, 2026 5:00 p.m. IST. Shareholders are requested to note that in case their PAN is not registered, the tax will be deducted at a higher rate of 20%.
 - b. Non-resident shareholders can avail beneficial rates under tax treaty between India and their country of residence, subject to providing necessary documents i.e. No Permanent Establishment and Beneficial Ownership Declaration, Tax Residency Certificate, Form 10F, any other document which may be required to avail the tax treaty benefits by sending an email to cs@tycheindustries.net. The aforesaid declarations and documents need to be submitted by the shareholders latest by September 23rd, 2026, 5:00 p.m. IST.
12. In compliance with the aforesaid MCA Circulars and SEBI Circulars, Notice of the AGM along with the Annual Report for FY 2025-26 is being sent only through electronic mode to those Members whose e-mail addresses are registered with the Company or Depository Participant(s). Shareholders are also requested to visit the website of the Company www.tycheindustries.net or the website of the Registrar and Transfer Agent <https://www.cilsecurities.com> or the website of the stock exchanges, BSE for downloading the Annual Report and Notice of the AGM.
13. Securities and Exchange Board of India ("SEBI") has mandated those securities of listed companies can be transferred only in dematerialised form w.e.f. 1 April 2019. Accordingly, the Company & Company's RTAs have stopped accepting any fresh requests for transfer of shares in physical form. Members holding shares in physical form are requested to avail of the facility of dematerialisation before initiating transfer of shares. Members holding shares in physical mode are requested to submit their Permanent Account Number (PAN) and bank account details to the Company / CIL Securities if not registered with the Company/ CIL Securities Limited, as mandated by SEBI, by writing to the Company at cs@tycheindustries.net or to CIL Securities Limited at rta@cilsecurities.com along with the details of Name & Folio no., self-attested copy of PAN card, self-attested scanned copy of Aadhaar Card / Passport / Driving Licence / Election Identity Card, bank details viz name of the Bank and branch address, Bank account number, IFSC & MICR details and a cancelled cheque and also further advised to register nomination in respect of their shareholding in the Company. Non-Resident Indian members are requested to inform CIL Securities Limited / respective DPs, immediately of any change in their residential



status on return to India for permanent settlement by submitting particulars of their bank account maintained in India with complete name, branch, account type, account number and address of the bank with pincode number, if not already furnished.

14. Pursuant to the circular issued by the Securities and Exchange Board of India (SEBI) bearing no. SEBI/HO/MIRSD/MIRSD-PoD/P/CIR/2025/97 dated July 2, 2025, a six-month window from July 7, 2025, to January 6, 2026, was provided for re-lodgement of physical share transfer requests. Subsequently, SEBI vide its circular dated January 30, 2026, has further extended this facility by opening a 'Special Window' for a fresh period of one year, from February 5, 2026, to February 4, 2027, to facilitate re-lodgement of such requests. This facility is applicable only to transfer deeds that were lodged prior to April 1, 2019, and were rejected, returned, or remained unprocessed due to deficiencies. Members holding such requests may resubmit them along with the requisite documents by following the prescribed process. Upon due verification, the shares will be transferred only in dematerialised form.
15. Item No. 4

In terms of the provisions of Section 148 of the act and rules made thereunder, the Company is required to maintain cost audit records and have the same audited by a Cost Auditor.

Based on the recommendation of Audit Committee, the Board of Directors at its meeting held on 28th May, 2026, appointed Mr. Sativada Venkat Rao, as Cost Auditor for conducting the cost audit for the financial year ending 31st March, 2027, on a remuneration of Rs. 45,000/- p.a (Rupees Forty-Five Thousand only) excluding taxes as may be applicable, in addition to reimbursement of all out-of-pocket expenses.

Rule 14 of Companies (Audit and Auditors) Rules, 2014 as amended, requires that the remuneration payable to the cost auditor be ratified by the Members.

Accordingly, consent of the members is sought for passing an Ordinary Resolution as set out at Item No.4 of the Notice for approval of the remuneration payable to the Cost Auditors for the financial year ending March 31, 2027.

The Directors recommend that the remuneration payable to the Cost Auditor in terms of the resolution set out at Item No. 4 of the accompanying Notice be ratified by the Members.

During the year, your Company has achieved a total income of Rs. 6285.63 Lakhs as against Rs. 7288.65 Lakhs in the previous year and earned a net profit of Rs. 693.70 Lakhs (Previous Year Rs 1240.72 Lakhs) after providing Income Tax and Deferred Tax of Rs.252.73 Lakhs (Previous Year Rs. 430.66 Lakhs).

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

GLOBAL PHARMACEUTICAL SCENARIO

In 2026, global health systems continue to demonstrate remarkable resilience, having adapted significantly in the aftermath of the COVID-19 pandemic, surging inflation, and ongoing regional conflicts. The pharmaceutical sector remains a critical pillar of global healthcare, with innovation, access, and affordability shaping the industry's trajectory.

At invoice price levels, the global pharmaceutical market is projected to grow at a compound annual growth rate (CAGR) of 5–8% through 2030, reaching a total estimated market size of approximately \$2.6 trillion.

This growth will be driven by the continued availability and use of innovative therapeutics in developed markets, offset by losses of exclusivity. Spending and volume growth are following diverging trends by region, with volume and spending drivers varying some regions are more volume-driven while others have a greater contribution from adoption of innovation with higher prices

A significant portion of future global medicine spending will be driven by existing branded products, which are expected to contribute the largest share of growth. Thirty countries are expected to drive global spending growth, all with spending in 2030 more than \$2 billion higher than in 2025. Half of these are developed countries with GDP per capita above \$50,000, and the other half are Pharmerging countries with robust pharmaceutical growth.

Growth Across Key Markets:

Global medicine spending is projected to grow at 5-8% CAGR through 2030 to reach about US\$ 2.6 Trillion. Developed market spendings are expected to grow at a 5-8% CAGR, driven by new products and increased adoption of existing branded medicines and offset by patent expiries. Meanwhile, pharmerging markets are set to grow at a faster pace of 10– 13% CAGR, fuelled by increased per capita medicine usage and the adoption of new medicines, with strong momentum in Latin America, Eastern Europe, and parts of Asia.

United States:

On a net price basis, U.S. pharmaceutical spending is projected to grow at a 4–7% CAGR over the next five years. Growth will be driven by adoption of newly launched innovative products, with an average of 50–55 new medicines launching per year, including those in oncology or with specific return-on-investment profiles. The largest driver of growth will be increased usage of existing protected branded products, expected to add \$378 billion in spending over five years. The Inflation Reduction Act (2022), benefit redesign for Medicare Part D, and the omnibus legislation of summer 2025 are reshaping how consumers pay for drugs.

Europe:

Spending in the top six European markets (Germany, UK, Italy, Spain, France, and Poland) ranges from \$41 billion to \$78 billion in 2025, with spending at invoice prices projected to grow modestly through 2030. Eastern European countries with higher historic growth, including Russia, Poland, Romania, and Türkiye, are projected to continue above-average growth. The recently announced U.S./UK trade deal includes an intention by the UK to increase spending on novel drugs as a percentage of GDP. EU-wide policies targeting security of supply,



harmonisation of health technology assessments, and incentives to industry will shape the market

Japan:

Medicine spending is forecast to remain nearly unchanged over five years, averaging 0.5 to 2.5% CAGR through 2030. Growth is driven by existing products and expected new launches, while offset by annual price cuts and expiries. Long-listed products (off-patent brands) face significant price erosion through biennial and annual pricing revisions. Average price cuts are projected in the 4–6% range, with larger cuts for every-year scheduled price cuts.

China:

Pharmaceutical spending has risen from \$112 billion in 2016 to \$166 billion in 2025 in constant USD. Over the past five years, spending growth was driven by protected original branded products, more often from multinational companies, which grew at an average of 18.2% per year. Over the next five years, protected original brands will slow to 8.4% per year while most other types of product will decline, contributing to overall growth slowing to 0–2%. The National Reimbursement Drug List (NRDL) updates and volume-based procurement (VBP) continue to drive down generic prices.

Latin America:

Growth is expected to 8–11% CAGR through 2030, led by strong performance in Brazil (the largest and among the fastest growing), Mexico, Argentina, and Colombia. Brazil's growth is driven by a combination of economic and policy drivers

India:

Spending growth is expected at 7–10% through 2030. Growth has been driven by volume over the past decade as 1.3 billion people expand usage in a largely out-of-pocket market. Most of the spending is driven by nonoriginal brands and unbranded generic drugs, supported by lower prices and robust domestic generics.

Middle East and North Africa:

Spending is expected to grow considerably, led by Saudi Arabia growing from \$15.5 billion to \$23.6 billion, driven by Vision 2030 goals including increasing life expectancy and promoting preventive healthcare. Egypt's growth is driven more by price growth amid currency devaluation. The UAE is expected to see more modest growth. Sub-Saharan Africa is projected to grow only 2.6% CAGR through 2030, spending only \$14 billion on medicines despite being home to 1.5 billion people

Key Areas of Global Medicine Spending

- **Biotech medicines** — those created through recombinant DNA technology — are expected to reach \$915 billion by 2030, about 34% of global medicine spending. Biotech covers a range of therapies, including traditional therapies such as insulin analogues and more complex specialty medicines and cell and gene therapies. Biotech drugs will see a 47% aggregate increase over the next five years. However, overall biotech growth will occur despite brand losses of \$50 billion due to biosimilars in developed markets.

Specialty medicines — those treating chronic, complex, or rare conditions, often requiring special handling, distribution, or patient monitoring — will represent about 46% of global



spending by 2030 and over 53% in leading developed markets, up from 34.9% and 36% respectively a decade earlier. Pharmerging countries have lagged, with only 18% of spending on specialty medicines in 2025.

Oncology: Expected to grow at 9–12% CAGR through 2030, reaching \$467 billion from \$291 billion in 2025. The PD-1 inhibitors pembrolizumab (Keytruda) and nivolumab (Opdivo), which combined accounted for 10% of global oncology spending in 2025, are expected to face biosimilar competition. This will be offset by continued uptake of novel modalities including ADCs, bispecific antibodies, and cell and gene therapies

Immunology: Projected to grow at 3.5–6.5% CAGR through 2030, reaching \$271 billion. Growth is offset by the impact of biosimilars, particularly biosimilar adalimumab (Humira), ustekinumab (Stelara), and tocilizumab (Actemra). New products in psoriasis, atopic dermatitis, and severe asthma have driven spending growth and are expected to continue.

Diabetes and Obesity: Diabetes spending in developed markets reflects both the consistent use of key therapies as a patient's Type 2 disease progresses and the adoption of novel therapies. GLP-1 therapies have risen to \$88 billion in spending globally. Obesity spending reached \$65 billion in 2025 and could reach \$105–\$200 billion by 2030.

Cardiovascular: Spending on therapies for cardiovascular diseases highlights the highly effective range of treatments where drugs have multi-use, including cardiovascular, heart failure, and diabetes. Novel GLP-1 receptor agonist therapies have been approved for cardiovascular indications, benefiting more patients. SGLT2 therapies, originally developed for diabetes, are now used more widely for cardiovascular prevention. Growth in cardiovascular therapies overall is projected at 2.5% CAGR through 2030

Neurology: New therapies in Alzheimer's and anxiety/depression are expected to drive spending growth. The anti-amyloid therapies aducanumab (Aduhelm, launched 2021), lecanemab (Leqembi, launched 2023), and donanemab (launched 2024) have seen limited adoption. Expected spending growth in mental health areas is currently higher than in neurology treatments, reflecting the effects of innovation for unmet needs.

Cell and Gene Therapies: In addition to the over 80 cell and gene therapies launched globally to date, an additional 20–25 are expected to be launched by 2030. Many of these therapies have very high costs which, combined with uncertain numbers of patients, are generating significant tension and resistance from payers. Health technology assessments (HTAs) are key to setting net prices, especially in Europe.

Global medicine spending is projected to grow at 6-9% CAGR through 2028 to reach about US\$ 2.3 Trillion. Developed market spendings are expected to grow at a 5-8% CAGR, driven by new products and increased adoption of existing branded medicines and offset by patent expiries. Meanwhile, pharmerging markets are set to grow at a faster pace of 10– 13% CAGR, fuelled by increased per capita medicine usage and the adoption of new medicines, with strong momentum in Latin America, Eastern Europe, and parts of Asia.

INDIAN PHARMACEUTICAL MARKET

The Indian pharmaceutical industry ranks as the third largest globally by volume, eleventh in terms of medicine spending, and fourteenth by value. India is the world's leading supplier of generic medicines, accounting for approximately 20% of global generic drug exports by volume



and serves over 200 countries. The country is recognised for its cost-effective and high-quality pharmaceutical products.

The API industry in India ranks third-largest in the world, supplying 57% of APIs on the pre-qualified WHO list, and constitutes ~8% share in the global API industry.

India's pharmaceutical exports rose from USD 30.47 billion in FY 2024-25 to USD 31.11 billion in FY 2025-26. The growth is largely driven by increased health insurance coverage, better access to healthcare facilities, growing prevalence of chronic diseases, and rising per capita income. Exports growth is expected to be fuelled by greater generic drug penetration in regulated markets, supported by a focus on niche and complex product segments, patent expiries, licensing agreements from the medicine patent pool, and rising demand from semi-regulated markets.

The country hosts the highest number of pharmaceutical manufacturing facilities approved by the U.S. Food and Drug Administration (USFDA). These facilities cater to a diverse range of segments, including generic drugs, over the counter (OTC) medications, active pharmaceutical ingredients (APIs), vaccines, biosimilars, and contract research and manufacturing services (CRAMS).

The Indian pharmaceutical market is projected to reach US\$ 130 billion by 2030 and US\$ 450 billion by 2047. This growth will be driven by a combination of factors such as increasing affordability and accessibility, a growing burden of lifestyle-related diseases, cost-effective production capabilities, and a supportive policy environment. Medicine spending in India is expected to grow at a compound annual rate of 7–10% through 2030, propelled by an ageing population, expanding healthcare access, and a rising prevalence of chronic conditions.

India's expanding network of trade agreements is strengthening its pharmaceutical industry by improving global market access, boosting exports, and enhancing competitiveness. Agreements with key partners such as the EU, the UK, and New Zealand are enabling reduced or zero-duty access for a wide range of pharmaceutical products, making Indian generics more competitive in international markets.

These partnerships are expected to drive export growth, attract investment, support MSME participation, and deepen integration into global healthcare value chains. Alongside these agreements, government initiatives such as Production Linked Incentive schemes, bulk drug and research support are reinforcing domestic manufacturing, reducing import dependence, and positioning India as a reliable global supplier of affordable medicines.

API sector:

APIs are a major export category and serve as key enablers for vertical integration across the industry. India's API exports are projected to expand from nearly US\$5 billion in 2023 to reach US\$12 billion by 2030, growing at a 14% CAGR during this period. The API exports are further poised to reach US\$80-90 billion with a 12% CAGR from 2030 to 2047, matching China's expected penetration by 2047 (Bain & Company Report; Pharmexcil 2023 Data).

Indian CDMO Industry

The India CDMO industry was valued at USD 26 billion in 2025 and is expected to grow to USD 57.94 billion by 2031, at 14.4% CAGR, led by cost-efficient production base, technically skilled workforce, and policy support from the government like the Production-Linked Incentive scheme.



With a view to diversify supply chains, global sponsors redirect high-value biologics and complex injectable mandates toward India.

The use of AI and digitisation in CDMO are being exploited to shrink development timelines and enhance quality consistency. On the global stage, India has built a strong brand equity as a preferred site for outsourced small and large-molecule manufacturing. The industry is witnessing multiple multinational investments in new greenfield facilities. Led by strong regulatory compliance mandates by CDSCO and the U.S. FDA, the industry has seen substantial shift towards superior quality systems, and higher compliance expenditures that ultimately strengthen export credibility

GLOBAL API INDUSTRY OVERVIEW:

Active Pharmaceutical Ingredients (APIs) continue to form the backbone of the global pharmaceutical industry, serving as the essential therapeutic components in pharmaceutical formulations. During FY 2025-26, the global API industry witnessed steady growth, driven by increasing healthcare expenditure, the rising prevalence of chronic diseases, an ageing population, expanding access to healthcare in emerging economies, and continued demand for generic medicines and specialty pharmaceuticals.

The global API market was valued at approximately US\$270.5 billion in 2025 and is projected to reach US\$419 billion by 2033, registering a compound annual growth rate (CAGR) of around 5.6% over the forecast period. Growth is being supported by increasing demand for innovative therapies, biologics, high-potency APIs (HPAPIs), peptides, and biosimilars, alongside sustained expansion in the generic pharmaceutical segment. Continuous investments in research and development, process intensification, and advanced manufacturing technologies are further enhancing production efficiency and product quality.

Asia-Pacific remains the fastest-growing API manufacturing region, with India strengthening its position as a preferred global manufacturing destination owing to its cost competitiveness, skilled scientific workforce, regulatory-compliant manufacturing facilities, and government initiatives to promote domestic API production. The increasing adoption of contract development and manufacturing (CDMO) services and the global shift towards diversified supply chains are expected to further support long-term growth prospects for Indian API manufacturers

Overall, the Company believes that its comprehensive risk management framework, supported by strong internal controls, operational excellence, regulatory compliance, and continuous improvement initiatives, enables it to effectively manage business risks and capitalize on emerging growth opportunities.

**NOTES TO FINANCIAL STATEMENTS FOR THE YEAR ENDED MARCH 31, 2026****1. Corporate Information**

Tyche Industries Limited is a public company domiciled in India and was incorporated under the provisions of the Companies Act applicable in India. The registered office of the Company is located at D.No.C-21/A, Road No.9, Film Nagar, Jubilee Hills, Hyderabad, Telangana-500096, India. The Company's shares are listed on the Bombay Stock Exchange (BSE).

The Company is principally engaged in manufacturing of active pharmaceutical ingredients.

The financial statements for the year ended 31st March, 2026 were approved by the Board of Directors and authorised for issue on 28th May, 2026.

2. STATEMENT OF PREPARATION, MEASUREMENT AND MATERIAL ACCOUNTING POLICIES**2.1 Statement of Compliance, Basis of Preparation and Presentation****a) Statement of Compliance**

The Financial statements of Tyche Industries Limited have been prepared and presented in accordance with Indian Accounting Standards (hereinafter referred to as the "IND AS") as notified by the Ministry of Corporate Affairs pursuant to section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time, other pronouncements of the institute of Chartered Accountants of India and guidelines issued by Securities and Exchange Board of India (SEBI).

The company's Internal Financial Control (IFC) over Financial Reporting is a process designed to provide reasonable assurance regarding the reliability of financial reporting and the preparation of financial statements for external purposes in accordance with generally accepted accounting principles which is being implemented by the company as a continuous process exercise required for providing reasonable assurance regarding the reliability of the financial reporting.

Accounting policies not referred to herein otherwise are consistent with Generally Accepted Accounting Principles in India.

These financial statements comprise the Balance Sheets as at 31st March, 2026 and 31st March 2025, the Statements of Profit and Loss, Statements of Changes in Equity and the Statements of Cash Flows for the year ended 31st March, 2026 and for the year ended 31st March 2025, and a summary of the significant accounting policies and other explanatory information (together hereinafter referred to as "Financial Statements").

The statement of cash flows has been prepared under indirect method.

b) Basis of Measurement

The Company follows the mercantile system of accounting and recognizes incomes and expenses on accrual basis. The accounts are prepared as a Going Concern and on Historical Cost basis except for the following:

- Certain Financial Assets and Liabilities are measured at fair value or amortised cost.
- Employee Defined Benefit Assets/Liability recognised as the net total of the fair value



of plan assets, and actuarial losses/gains, and the present value of defined benefit obligation

c) Functional & presentation Currency

These financial statements are presented in Indian rupees (Rs), which is also the functional currency of the Company.

d) Use of Estimates:

The preparation of the Financial Statements in conformity with Ind AS requires management to make estimates, judgements and assumptions. These estimates, judgements and assumptions affect the application of Accounting Policies and the reported amounts of Assets and Liabilities, the disclosures of contingent assets and liabilities at the date of the financial statements and reported amounts of Revenues and Expenses during the period. Accounting estimates could change from period to period. Actual results could differ from those estimates. Appropriate changes in estimates are made as management becomes aware of changes in circumstances surrounding the estimates. Changes in estimates are reflected in the financial statements in the period in which changes are made and, if material, their effects are disclosed in the notes to the financial statements.

The key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next Financial Year, are described below. The Company based on its assumptions and estimates on parameters available when the Financial Statements were prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising that are beyond the control of the Company. Such changes are reflected in the assumptions when they occur.

i. Defined employee benefit plan (Gratuity):

The cost of the Defined Benefit Gratuity Plan and other accumulated leave entitlement and the present value of the gratuity obligation and accumulated leave obligation are determined using actuarial valuations. An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate; future salary increases and mortality rates. Due to the complexities involved in the valuation and its long-term nature, a defined benefit obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each reporting date.

The parameter most subject to change is the discount rate. In determining the appropriate discount rate for plans operated in India, the management considers the interest rates of government bonds in currencies consistent with the currencies of the postemployment benefit obligation.

The mortality rate is based on publicly available mortality tables for the specific countries. Those mortality tables tend to change only at interval in response to demographic changes. Future salary increases and gratuity increases are based on expected future inflation rates.

**ii. Impairment of non-financial assets**

Impairment exists when the carrying value of an asset or cash generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The fair value less costs of disposal calculation is based on available data from binding sales transactions, conducted at arm's length, for similar assets or observable market

iii. Impairment of investments

The Company reviews its carrying value of investments annually, or more frequently when there is an indication for impairment. If the recoverable amount is less than its carrying amount, the impairment loss is accounted for.

iv. Inventories

- a) Raw materials, packing materials, stores, spares, consumables are valued at cost, after providing for obsolescence, if any or Net realizable Value (NRV) whichever is lower.
- b) Work-in-progress, finished goods are valued at cost of raw material plus proportionate overheads or Net realizable value whichever is lower as mandated by ICAI. Cost includes all charges incurred for bringing the materials to the location of the manufacturing facilities.

The Company estimates the net realisable value (NRV) of its inventories by taking into account their estimated selling price, estimated cost of completion, estimated costs necessary to make the sale, obsolescence by applying certain percentages over different age category of such inventories, expected loss rate considering the past trend and future outlook. Inventories are written down to NRV where such NRV is lower than their cost.

Inventory write downs are accounted considering the nature of inventory, estimated shelf life, planned product discontinuances, price changes, ageing of inventory and introduction of competitive new products as well as the provisioning policy. Write downs of inventories amounted to Rs.1,04,85,430.

e) Current and Non current classification

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria as set out in the Division II of Schedule III to the Companies Act, 2013. Based on the nature of products and the time between acquisition of assets for processing and their realisation in Cash and Cash Equivalents, the Company has ascertained its Operating Cycle as 12 months for the purpose of current or non-current classification of assets and liabilities.

2.2 Material Accounting Policies:**A. Revenue Recognition:**

Effective April 1, 2018, the Company has applied Ind AS 115: Revenue from Contracts with Customers which establishes a comprehensive framework for determining whether, how much and when revenue is to be recognised. Ind AS 115 replaces Ind AS 18 Revenue. The impact of the adoption of the standard on the financial statements of the Company is



insignificant.

The specific recognition criteria described below must also be met before revenue is recognised:

Sale of goods: Revenue from sale of goods is recognised when a promise in a customer contract (performance obligation) has been satisfied by transferring control over the promised goods to the customer. Control is usually transferred upon shipment, delivery to, upon receipt of goods by the customer, in accordance with the delivery and acceptance terms agreed with the customers. The amount of revenue to be recognised is based on the consideration expected to be received in exchange for goods, excluding trade discounts, volume discounts, sales returns and any taxes or duties collected on behalf of the government which are levied on sales such as sales tax, value added tax, goods and services tax, etc., where applicable. Any additional amounts based on terms of agreement entered into with customers, is recognised in the period when the collectability becomes probable and a reliable measure of the same is available.

As mentioned above, as per the requirements of “Ind AS 115 – Revenue from Contracts with Customers”, Revenue should be recognized when control of the goods is transferred to the customer. However, the company has been consistently practicing the recognition of Revenue on Sales upon dispatch of goods upto Balance Sheet Date, control for which was transferred after the Balance Sheet Date but before the Financial Statements preparation and approval Date, This results in understatement or overstatement of Turnover and Net Profit After Tax for the Year and consequently Reserves at the end of the year.

Rendering of services: Milestone payments and Development/Licensing arrangements

Revenues include amounts derived from product Development/licensing agreements. These arrangements typically consist of an initial up-front payment on inception of the arrangement and subsequent payments dependent on achieving certain milestones in accordance with the terms prescribed in the agreement. Non-refundable up-front license fees received in connection with product out-licensing agreements are deferred and recognised over the period in which the Company has continuing performance obligations. Milestone payments which are contingent on achieving certain clinical milestones are recognised as revenues either on achievement of such milestones, if the milestones are considered substantive, or over the period the Company has continuing performance obligations, if the milestones are not considered substantive.

Interest income: Interest income is recognised with reference to the Effective Interest Rate (EIR) method.

Export benefits, incentives and licenses: Export incentives are recognised as income when the right to receive credit as per the terms of the scheme is established in respect of the exports made and where there is no significant uncertainty regarding the ultimate collection of the relevant export proceeds.

B. Property, Plant and Equipment.

Items of Property, Plant and Equipment, are measured in the Financial Statements at Cost of Acquisition or Construction less Accumulated Depreciation and Accumulated Impairment. The cost of an item of property, plant and equipment comprises its purchase price, including import duties and non-refundable purchase taxes, after deducting Trade Discounts and



Rebates and any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

Borrowing costs directly attributable to acquisition or construction of those fixed assets which necessarily take a substantial period of time to get ready for their intended use are capitalised.

Subsequent expenditure related to an item of property, plant and equipment is capitalized only if it enhances the future economic benefits arising from the existing assets beyond its previously assessed standards of performance.

Measurement of any class of Property, Plant and Equipment, for any subsequent periods other than initial recognition period is stated adopting Cost model.

C. Borrowing cost

Borrowing cost includes interest incurred in connection with the arrangement of borrowings and exchange differences arising from foreign currency borrowings to the extent they are regarded as an adjustment to the interest cost.

D. Depreciation

Depreciation on property, plant and equipment is provided based on Straight Line basis on useful lives of assets as prescribed in Schedule II to the Companies Act, 2013. Depreciation is calculated on a pro-rata basis from the date of installation till the date the assets are sold or disposed. Land is not depreciated. Software for internal use, which is primarily acquired from third-party vendors and which forms integral part of tangible asset, including consultancy charges for implementing the software, is capitalised as part of the related tangible asset. Subsequent costs associated with maintaining such software are recognised as expenses. The capitalised costs are amortized over the estimated useful life of the software or the remaining useful life of the tangible fixed asset, whichever is lower.

E. Investments:

Investments which are readily realisable and intended to be held for not more than 12 months are classified as current investments. All other investments are classified as long-term investment. Current investments other than financial assets are carried at the lower of cost and fair value. Long-term investments other than financial assets are carried at cost less diminution in value, if any. Investments which are financial assets are valued at their fair value.

F. Impairment of Assets:

An asset is treated as impaired when the carrying cost of asset exceeds its recoverable value. An impairment loss is charged to the Statement of Profit and Loss in the year in which an asset is identified as impaired. The impairment loss recognised in prior accounting period is reversed if there has been a change in the estimate of recoverable amount. In the opinion of the Management, during the year there is no impairment loss.

G. Foreign exchange transactions and translations

The Financial Statements are presented in Indian rupees, which is the functional currency of the Company and the currency of the primary economic environment in which the Company operates.



Initial recognition: Foreign currency transactions are recorded in the functional currency, by applying to the foreign currency amount the exchange rate between the functional currency and foreign currency at the date of the transaction.

Conversion: Foreign currency monetary items are reported at functional currency spot rate of exchange at the reporting date. 'Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value is determined. The gain or loss arising on translation of non-monetary items measured at fair value is treated in line with the recognition of the gain or loss on the change in fair value of the item (i.e., translation differences on items whose fair value gain or loss is recognised in OCI or profit or loss are also recognised in OCI or profit or loss, respectively).

Exchange differences: Exchange differences arising on the settlement of monetary items or on reporting monetary items of the Company at rates different from those at which they were initially recorded during the year, or reported in previous financial statements, are recognised as income or as expenses in the year in which they arise.

H. Research & Development Expenditure:

Research costs are expensed as incurred. Development expenditures on an individual project are recognised as an intangible asset when the Company can demonstrate:

- The technical feasibility of completing the intangible asset so that the asset will be available for use or sale
- Its intention to complete and use or sell the asset
- Its ability to use or sell the asset
- How the asset will generate future economic benefits
- The availability of resources to complete the asset
- The ability to measure reliably the expenditure during development

Acquired research and development intangible assets that are under development are recognised as Intangible assets under development. These assets are not amortised, but evaluated for potential impairment on an annual basis or when there are indications that the carrying value may not be recoverable. Any impairment is recognised as an expense in the statement of profit and loss.

I. Government grants and subsidies

Government grants are recognised when there is reasonable assurance that the grant will be received and all attached conditions will be complied with. When the grant relates to an expense item, it is deducted from the related expense. When the grant relates to an asset, it is recognised as deferred income and amortised over the useful life of such assets.

J. Taxes on Income:

Tax expenses for the year comprises of Current Tax and Deferred Tax. Provision for Current Taxes are made based on the Tax Rates and Tax laws as applicable to the Financial Year. Provision for Deferred tax on account of timing difference is calculated as per Ind AS-12



("Income taxes") prescribed by ICAI on the temporary differences (both taxable and deductible temporary differences) in carrying amount of the assets and liabilities as at the reporting date on the carrying value and the amounts used for taxation purposes. Income tax expense is recognised in the statement of profit and loss except to the extent that it relates to items recognised in the equity, in which case it is recognised in equity.

K. Employee benefits**Short- Term Employee Benefits:**

Short-term employee benefits are expensed as and when the service is rendered by employee. A liability is recognised for the amount expected to be paid if the Company has a present legal or constructive obligation to pay this amount as a result of past service provided by the employee and the obligation can be estimated reliably.

Defined Contribution Plan:

The Companies liability towards retirement benefits in the form of Provident Fund and ESIC are considered as defined contribution plan and the contributions are charged to the statement of Profit & Loss during the year when the contributions to the respective funds are due. The company contributes to the employees Provident Fund maintained under Statutory Provident Fund Scheme.

Defined Benefit Plan:

The Company operates defined benefit plans for gratuity. The cost of providing such defined contribution is determined using the Projected Unit Credit Method (PUCM). The accruing liability towards Gratuity and other retirement benefits are provided on the basis of Actuarial Valuation made by an independent Actuary. The Company fully contributes all ascertained liabilities to the "Tyche Industries Limited Employees Gratuity Trust" (Trust). Trustees administer contributions made to the Trust through a fund managed by Life Insurance Corporation of India (LIC). The Actuarial gains and losses are recognised immediately in the statement of profit and loss account as income or expense.

L. Financial Instruments:**I. Financial Assets:****i. Initial Recognition and Measurement.**

All Financial Assets are initially recognized at Fair Value. Transaction costs that are directly attributable to the acquisition or issue of Financial Assets, which are not at Fair Value Through Profit and Loss are adjusted to the Fair Value on initial recognition. Purchase and sale of Financial Assets recognized using trade date accounting.

ii. Subsequent Measurement:

- A Financial Asset is measured at Amortized Cost if is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial Asset give rise on specified dates to cash flows that represent solely payments of principal and interest on the principal amount outstanding.



This category is the most relevant to the Company. After initial measurement, such financial assets are subsequently measured at amortised cost using the Effective Interest Rate (EIR) method. Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the EIR. The EIR amortisation is included in finance income in the statement profit and loss. The losses arising from impairment are recognised in the statement profit and loss. This category generally applies to trade and other receivables, Cash and Bank Balances, Deposits and Loans, etc.

- Financial Assets measured at Fair Value through other Comprehensive Income (FVTOCI)

Financial Assets is measured at FVTOCI if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the Financial Assets and the contractual terms of the Financial Asset give rise on specified dates to cash flows that represents solely payments of principal and interest on the principal amount outstanding.

- Financial Assets measured at Fair Value Through Profit or Loss (FVTPL)

A financial Asset Which is not classified in any of the above categories are measured at FVTPL. Financial Assets are reclassified subsequent to their recognition, if the Company changes its business model for managing those financial assets. Changes in business model are made and applied prospectively from the reclassification date which is the first day of immediately next reporting period following the changes in business model in accordance with principles laid down under Ind AS 109.

This category is generally applied to Investments in equity shares, Investments in units of mutual funds, derivative instruments, investments primarily held for trading purposes.

iii. Impairment of Financial Assets:

In accordance with Ind AS 109, the company uses Expected Credit Loss (ECL) model, for evaluating impairment of Financial Assets other than those measured at Fair Value through Profit and Loss (FVTPL). Expected credit Losses are measured through a loss allowance at an amount equal to--

- The 12 Months expected credit losses (expected credit losses that result from all those default events on the financial instrument that are possible within 12 months after the reporting date.); or
- Full life time expected credit losses (expected credit losses that result from all possible default events over the life of the financial instrument.)

For trade receivables the Company applies "Simplified approach" which requires expected lifetime losses to be recognized from initial recognition of the receivables.

The Company uses historical default rates to determine impairment loss on the portfolio of trade receivables. At every reporting date these historical default rates are reviewed and changes in the forward – looking estimates are analysed.

For other assets, the company uses 12-months ECL to provide for impairment



loss where there is no significant increase in credit risk. If there is significant increase in credit risk full life time ECL is used.

II. Financial Liabilities:**i) Initial Recognition and Measurement**

All Financial Liabilities are recognized at fair value and in case of borrowings, net of directly attributable cost, fees of recurring nature and directly recognized in the statement of Profit and Loss as finance cost.

ii) Subsequent Measurement:

Financial Liabilities are carried at amortized cost using the effective interest method. For trade and other payables maturing within one year from the balance sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

M. Provisions

A provision is recognized when the Company has a Present Obligation as a result of Past Event and it is probable that an outflow of resources will be required to settle the obligation in respect of which a reliable estimate can be made. Provisions are not discounted to its present value and are determined based on best estimate required to settle the obligation at the balance sheet date. These are reviewed at each balance sheet date and adjusted to reflect the current best estimates.

The Company's activities expose it to variety of financial risks, foreign currency risk, interest rate risk, credit risk, commodity price risk and liquidity risk. Within the boundaries of approved Risk Management Policy framework, the Company manages the volatility and minimize the adverse impact on its financial performance.

i) Credit Risk:

Credit Risk is the risk that a customer fails to perform or pay the amounts due causing financial loss to the company. Credit risk arises from dealing in derivatives, receivables from customers and other financial instruments. The company maintains that, Credit Risk is actively managed through continuous follow up with the parties and Credit information is regularly shared between business and financial function, with a framework in place to quickly identify respond and recognize cases of credit deterioration.

ii) Liquidity risk

Liquidity risk arises from the Company's inability to meet its cash flow commitments on the due date. The company's liquidity is managed centrally with all the departments forecasting their cash and liquidity requirements. Management monitors rolling forecasts of the company's cash flow position to ensure that the company is able to meet its obligation.

iii) Market Risk

a. Foreign Currency Risk

The fluctuation in foreign currency exchange rates may have potential impact on the statement of profit or loss, where any transaction references more than one currency or where assets / liabilities are denominated in a currency other than the functional currency of the Company. The Company is subject to foreign exchange risk primarily due to its foreign currency revenues, expenses and borrowings. Considering the countries and economic environment in which the Company operates, its operations are subject to risks arising from fluctuations in exchange rates in those countries. The risks primarily relate to fluctuations in US Dollar, Euro and GBP against the functional currency of the Company.

**b. Interest Rate Risk:**

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of change in market interest rates. The Company is not exposed to any interest rate risk as currently there are no borrowings made by the company and also the interest-bearing assets held by the company are short term (maturity within 12 months) and are substantially independent of change in market interest rates.

c. Commodity Price Risk:

Commodity price risk arises due to fluctuation in prices of the major imported raw materials and other products. The company has a risk management framework headed by the managing director, aimed at prudently managing the risk arising arising from the volatility in commodity prices and freight costs.

34. Segment Reporting:

- i. Company's operations are predominantly related to the manufacture and processing of bulk drugs & intermediates, as such there is only one primary reportable segment. Secondary reportable segments are identified taking into account the geographical markets available to the products, the differing risks, returns and internal reporting system. Hence the segmental reporting is based on Domestic and Export sales.
